#### Introduction

Every child deserves a safe childhood free from violence or abuse. For 32 years, the Empowering Children Foundation (Fundacja Dajemy Dzieciom Siłę), hereinafter referred to as the "Foundation", has:

- protected children from violence and sexual abuse;
- provided children and their caregivers with support and professional mental health and legal assistance;
   educated adults on how to respond to child abuse wisely and effectively and what to do when they suspect a child may have been abused;
- supported and engaged parents so that they raise their children with love and respect;
- influenced the Polish law to ensure the best possible protection of children's interests.

2022 in numbers:

- 425 children provided with direct assistance;
  763 caregivers using psychological support;
  4,417 psychological consultations and individual therapy sessions for children;
  5,819 psychological consultations and individual therapy sessions for caregivers;
  54,808 helpline calls from Polish and Ukrainian children and young people;
  9,330 children and more than 280,000 adults provided with assistance within a regranting programme targeted at persons from Ukraine seeking refuge in Poland;
  23,922 participants in our conferences and training;
- **107,081** persons who signed our petitions and appeals.

The outbreak of the war in Ukraine in February 2022 had a significant impact on the expansion of the Foundation's activities in 2022 and in the following years. The Foundation was invited by foreign and domestic organisations, including Terre des Hommes, Plan International, Unicef, World Childhood Foundation, Orange, and Smyk, as a partner in assistance efforts for refugees from Ukraine. The Foundation undertook the implementation of regranting programs supporting NGOs that provide direct assistance to children and their caregivers staying in Poland. The Foundation also expanded its mission-related activities to assist children and their families, targeting them at persons from Ukraine.

Funds from the 1% tax donation scheme are used to finance mission-related activities in the area of helping children and their families, administrative costs, and fixed assets related to specific activities. The Foundation runs a dedicated register of expenses financed by the 1% programme.

In total, in 2022, the Foundation awarded grants to other organizations providing assistance to Ukrainian citizens in the amount of 8.3 million Polish zloty, of which 3.7 million was settled by December 31, 2022. The remaining grant projects are still being implemented and will be settled in 2023.

The Foundation uses loans granted by Towarzystwo Inwestycji Społeczno-Ekonomicznych SA, with an interest rate ranging from 0.88 to 1.88%. Loan repayments are made on an ongoing basis at dates specified in loan agreements.

Loans granted by Towarzystwo Inwestycji Społeczno-Ekonomicznych SA, secured by promissory notes and a mortgage on real estate owned by the Foundation, amounting to 1,110 thousand PLN.

### 7. Accruals

Mission-related revenues, which include grants, donations, and 1% of income tax for public benefit organizations (OPP), are recognised in the profit and loss statement when the entity acquires rights to receive the type of revenue resulting from ownership rights to these assets. For grants allocated for specific activities and actions, any unspent amount is deferred in the balance sheet and recognised under accruals in an amount corresponding to the costs incurred to grant-funded activities.

### 10. Contingent liabilities

Regulations regarding value-added tax, corporate income tax, personal income tax, property tax, or social security contributions are subject to change, which often results in the lack of reference to established regulations or legal precedents. Moreover, the existing regulations contain ambiguities, leading to differences of opinion as to the legal interpretation of tax laws, both among state bodies and between state bodies and business organisations. Tax returns and other settlements (e.g., customs or foreign exchange) may be subject to inspection by authorities authorised to impose substantial penalties, and any additional amounts of liability determined by such an inspection must be paid along with interest. As a result, tax risk in Poland is higher than typically exists in countries with more developed tax systems.

Tax returns may be subject to audit for a period of five years. As a result, the amounts reported in the financial statements may change at a later date after final determination by tax authorities. The Foundation has not been subjected to a tax audit.

### 16. Impact of the COVID- 19 pandemic and the war in Ukraine

In 2022, the Empowering Children Foundation continued its operations steadily and continuously, utilising a hybrid work system and electronic communication channels. According to the Regulation by the Minister of Health of the 16<sup>th</sup> of May 2022, the state of epidemic in Poland was cancelled, replaced by the state of epidemic emergency, which did not affect the Foundation's mode of operation.

Following the outbreak of full-scale war in Ukraine on the 24<sup>th</sup> of 2022, the Empowering Children Foundation engaged in humanitarian efforts and provided immediate assistance to persons fleeing from Ukraine, which involved hiring Ukrainian-speaking staff. Additionally, the FDDS supported other locak NGOs through regranting and training in child protection.
