

The Empowering Children Foundation (formerly Nobody's Children Foundation) works toward making sure that all children have a safe childhood and are treated with respect for their dignity, as full-fledged human beings.

We protect children and support those who have experienced abuse to help them know their rights, believe in themselves, and enjoy their lives.

# In carrying out our mission we:

- Offer psychological and legal help to abused children and their caregivers
- Teach children how to avoid violence and abuse
- Teach adults how to treat children and what they can do to protect them from abuse
- Tell adults what to do when they suspect a child might have been abused
- Influence the Polish law to insure the best possible protection of children's interests.

2016 was a special year for the Foundation. On the 25th anniversary of the Nobody's Children Foundation we decided to change the name. As a result of identifying new social needs and broadening the scope of the Foundation's activity, the old name no longer captured the area and purpose of our new activities. Today we work as the Empowering Children Foundation. The new name accurately conveys our goals, and the effects and multidimensional nature of our work. The Foundation's mission remains unchanged: to work for children. We protect them from abuse and we help those who have experienced abuse.

Another reason why 2016 was an important year was the opening of the Foundation's first regional branch in Pomorze (Pomerania). The Crisis Intervention Centre in Gdańsk and the Crisis Intervention Point in Starogard Gdański are our new facilities that implement the Foundation's mission in the Pomerania region.

# **Child Advocacy Centre**

programme carried out since 2003

**Goals:** To provide interdisciplinary help for child victims and their families or caregivers.

**Main activities:** Psychological, psychiatric, and legal help for child victims and their families, supporting professionals who help child victims.

- Psychological and pedagogical counselling, psychiatric consultations, legal advice, and individual therapy for child victims, their parents, and caregivers; crisis intervention in cases of suspected crimes against children (especially child sexual abuse and other forms of abuse)
- Consultations for professionals (psychologists, pedagogic counsellors, health care professionals, and social workers) in cases involving child abuse
- Individual supervisions for graduates from the course on preparing forensic psychological opinions in cases involving children
- Training for students of the Warsaw Medical University on child abuse prevention (51 hrs., 350 participants)
- Training for police officers (16 hrs., 24 participants)
- Running two groups for parents (psycho-educational and Trauma-Focused CBT) and a support group for mothers
- Running a Trauma-Focused CBT group and a socio-educational group for children and young people
- Conducting individual and group meetings for children and parents: Preparing child victims and witnesses for interviews (110 participants)
- Consultations for mothers of immigrant children at centres for foreigners (100 participants)
- Supervision for members of the Warsaw Network for Helping Children, psychology court experts, employees of residential care institutions, employees of centres for refugees/foreigners, and other professionals
- Running a child friendly interview room (151 interviews)
- Forensic examinations

- Being questioned as witnesses at the prosecutor's office / in court in cases involving the Centre's clients
- Taking part in the development of standards of hearing children in civil procedures and standards of the guardian ad litem
- Coordinating the Warsaw Network for Helping Children
- · Participating in meetings of multidisciplinary teams
- Developing a lesson plan within the Trauma Focused CBT programme
- Carrying out a trainee programme.

# Warsaw Network for Helping Children

programme carried out since 2010



**Goals:** To improve access to assessment/diagnosis and intervention in cases of suspected sexual abuse and to psychological help for sexually abused children.

Main activities: Assessment/diagnosis, intervention, and psychological help in cases of child sexual abuse; consultations for parents and professionals in situations of child sexual abuse.

# Programme activities in 2016:

The Warsaw Network for Helping Children comprises 27 institutions located in all districts of Warsaw, providing psychological help in cases of child sexual abuse. The Network's activities are coordinated by the Empowering Children Foundation.

In 2016 therapists of the Irena Kornatowska Child Advocacy

Centre trained psychologists and pedagogic counsellors working at the Network's institutions and conducted supervision sessions for them. Furthermore, the Centre organized training for professionals from the Network's institutions and conducted individual consultations (face-to-face and on the phone) for professionals.

- 1061 consultations for professionals within the WNHC
- 29 legal interventions in cases of suspected child sexual abuse.

# Good Parent - Good Start

programme carried out since 2007

**Goals:** To protect young children (0–6) from abuse by supporting and educating their parents/caregivers in parenting without violence; to promote good parenting.

**Main activities:** Direct support for parents with young children (education, psychological help, workshops); support for professionals working with parents of young children; supporting multidisciplinary work.

# We Protect Children

programme carried out since 2010 10 roku



"We Protect Children" is an original child abuse prevention programme carried out by the Empowering Children Foundation in cooperation with the Ministry of National Education and local authorities. The goal of the programme is to protect children from violence inflicted by adults (such as parents or institutional staff) and peers. The programme is carried out by implementing the child protection standards defined in the Child Protection Policy adopted by institutions. Institutions that meet the standards of protecting children from abuse are granted "We Protect Children" certificates.

## Programme activities in 2015:

- Managing the process of granting certificates to education, care, and other institutions that meet the child protection standards
- Training for professionals on topics including: identifying symptoms of abuse and intervention in cases of child abuse, standards of protecting children and implementing the Child Protection Policy in institutions, legal aspects of child protection, and preparation for conducting classes for children and parents
- Organizing local conferences about the programme
- Creating and coordinating a network of institutions supporting the activities carried out within the "We Protect Children" programme

**Goals:** To improve the child protection system in countries of Eastern Europe through increasing professionals' skills, helping child victims and their families, and raising public awareness. Since September 2014 the programme has focused on preventing sexual abuse of children and young people.

Main activities: Social campaigns, training, and supervisions provided by Polish and foreign experts; publications targeted at professionals, parents, and children; participating in conferences and study visits. Goals: To prevent and counteract the abuse of foreign children whose families are seeking international protection in Poland Main activities: Implementing the standards of child protection at centres for immigrants/foreigners, increasing the knowledge of the centres' staff about protecting children from abuse and helping children at risk, improving parenting skills among foreign children's parents, providing children with knowledge about how to avoid risky situations and where to seek help and support.

**Goals:** To prevent commercial child exploitation by raising awareness and knowledge among professionals and the society as a whole.

Main activities: Organizing and providing training for professionals, raising awareness through publications and a dedicated website, assessing the efficiency of the system for protecting child victims of trafficking and children at risk, lobbying/advocacy efforts for implementing model solutions and initiating a public debate about the situation of children at risk of commercial exploitation.

From 2010 to 2013 the Empowering Children Foundation (formerly Nobody's Children Foundation) carried out a grant programme "Safe Childhood", funded by the VELUX Foundations. The programme was targeted at NGOs that support local communities in protecting children from violence and abuse. The "Safe Childhood" programme supported the implementation of projects in the areas of keeping children safe online, preventing abuse of young children, and helping child victims of crime and abuse. The programme has been continued in the years 2013-2017.

# **Legal Department**

Goals: To provide legal help for the Empowering Children Foundation's clients and in-house legal advice/services; to improve the situation of children participating in legal procedures through education and raising awareness among professionals, and lobbying/advocacy for legislative changes (in relation to children).

Main activities: Face-to-face, telephone and online consultations for the Foundation's clients; handling the legal aspects of the Foundation's programmes and undertaking legal interventions. As part of the "Child Friendly Justice" programme – granting certificates to Child Friendly Interview Rooms to improve the quality of facilities where children are interviewed; conducting training for judges, prosecutors, police officers, and court experts, as well as for psychologists and pedagogic counsellors on how to prepare children for interviews and how to interview children; publishing activity targeted at professionals, parents, and child witnesses. Training for parents of children involved in legal procedures, advocacy for the protection of children's interest through the role of guardian ad litem, representing child victims in criminal procedures. Running the "Child Victim Advocate" voluntary service.

### **Crisis Intervention Centre (CIC)**

**Goals:** To provide crisis intervention services accruing from the Social Services Act and to perform activities aimed at protecting children from abuse

Main activities: Running a 24/7 crisis intervention centre; psychological interventions in crisis or near crisis situations; intervention services for victims of violence (adults and children); free of charge temporary shelter at the Crisis Hotel, support for parents of young children within the Gdańsk Parent Academy (education, workshops); supporting professionals working with parents of young children (conferences).
