

The Empowering Children Foundation works to ensure that all children have a safe childhood and are treated with respect for their dignity and personal autonomy. We protect children from maltreatment and support those who have experienced abuse to help them know their rights, believe in themselves, and enjoy their lives.

In carrying out our mission we:

- Offer psychological and legal help to abused children and their caregivers
- Teach children how to avoid violence and abuse
- Teach adults how to treat children and what they can do to protect them from abuse
- Tell adults what to do when they suspect a child might have been abused
- Influence the Polish law to ensure the best possible protection of children's interests.



In 2019 the Foundation carried out the following programmes and projects:

Network of Child Advocacy Centres



Since 2018 the ECF has coordinated the work of 5 facilities – Child Advocacy Centres based on the Barnahus model. The model assumes that child victims of crime, mainly sexual and physical abuse, and their caregivers are provided with comprehensive, multidisciplinary help under one roof. The Child Advocacy Centres apply common standards and regard children's wellbeing as their central value. They offer child-friendly interview settings for children

involved in criminal procedures, as well as medical, mental health, and legal support. The facility's multidisciplinary team works in cooperation with local services. At the moment, the ECF runs three such Centres: in Gdańsk, Starogard Gdański, and Warsaw. The other two facilities are operated by the Foundation's partner organizations: the Szansa (Chance) Association in Głogów and the Klanza Association in Białystok.

Child Advocacy Centre in Warsaw



Goals: To provide interdisciplinary help for child victims and their families or caregivers.

Main activities: Psychological, psychiatric, and legal help for child victims and their families; supporting professionals who help child victims.

Goals: To protect young children (under 6) from abuse by supporting and educating their parents/caregivers in parenting without violence; to promote good parenting.

Child Protection Standards

Child Protection Standards (formerly "We Protect Children") is an original child abuse prevention programme carried out by the Empowering Children Foundation in cooperation with local authorities and partner organizations. The goal of the programme is to protect children from violence inflicted by adults (such as parents or residential staff) and by peers. The programme is carried out by implementing child protection standards, including the Child Protection Policy. Facilities that meet the standards of protecting children from abuse are granted "We Protect Children" certificates.

- Implementing the "Nurseries at the Start" project for staff members of Warsaw nurseries
- Training for professionals on topics including: identifying symptoms of abuse and intervening in cases of child abuse, and implementing the Child Protection Policy in facilities; legal aspects of child protection; preparation for conducting classes for children and parents on preventing abuse and protecting children and young people from sexual exploitation in tourism; psychological intervention in child abuse cases; and identifying symptoms of abuse of young children by child care staff in nurseries
- Organizing internal, tailor-made training
- Developing publications: "How to Protect Children from Sexual Abuse? A Manual for Parents", "How to Protect Children from Sexual Abuse? A Manual for Professionals", and a lesson script "Chatting with a Dog 1 & 2".

Childhood without Abuse

Goals: To improve the child protection system in countries of Eastern Europe through improving professionals' skills, helping child victims and their families, and raising public awareness. From September 2014 to August 20919 the programme focused on preventing sexual abuse of children and young people.

Legal Department

Goals: To provide legal help for the Empowering Children Foundation's clients and in-house legal advice/ services; to improve the situation of children participating in legal procedures through education and raising awareness among professionals, and advocacy for legislative changes in the area of child protection.

Main activities: Face-to-face and telephone consultations for the Foundation's clients; handling the legal aspects of the Foundation's programmes and providing legal interventions. As part of the "Child Friendly Justice" programme: conducting training for judges, prosecutors, legal counsels, police officers, and court appointed experts, as well as for psychologists and pedagogic counsellors on how to prepare children for interviews and how to interview children; publishing activity targeted at professionals, parents, and child witnesses. Workshops for parents of children involved in legal procedures, advocacy for introducing the institution of guardian ad litem, representing child victims in criminal procedures. Acting as guardians ad litem for child victims. Carrying out a legal programme "Child Victim Advocate", in which volunteers provide email consultations on child abuse prevention and accompany the Foundation's clients during court trials.
